5. Council on Homelessness Governance Charter & Bylaws

- a. Presented by Amanda Wehrman, Homebase
- b. An Ad Hoc Governance Charter and Bylaws Committee reviewed the changes and the changes were posted 2 weeks ago
- c. Changes to note:
 - Collapsed the bylaws and charter into one document
 1. Governance Charter is the foundational document that established the Council on Homelessness
 2. Bylaws: How we carry out the business of the Council
 - Cleaned up the consistency of the document and clarified H3's role and naming conventions
 - Transparency & Equitable Practices Section
 1. Refreshed the language and encouraged thinking about equity and transparency in how the Council and the larger CoC functions
 2. More inclusive language
 - P.10 Selection of Council Members
 1. List at the top of page 10 was refreshed to reflect the language in the HUD CoC NOFA
 - P.11 Retooled how we structured the section. No major changes around eligibility but more around how its drafted.
 - P. 12 Updated information about the standing committees
 1. Information now reflects the committees that are currently standing
 2. Still have ad hoc committees as needed
 - Clarification around H3's role on staffing and record keeping
 - Cleaned up the Code of Conduct

- Last page is a timeline of the Council of Homelessness in its various iterations since 1986
- d. Doug: I was on the Ad Hoc Committee that worked on this.
 - One of the clean-up items was in Section 9, top of p.12
 - Used to say that an amendment required a majority vote of the Council but then said 2/3s. We kept 2/3s as it is the higher bar
 1. Until this is passed and approved, both bars apply. So need to hit the higher bar. Which means we need 12 yes votes from the Council.

6. System Report Out: 2019 Point-in-Time Count (PIT) Count, System Mapping Meeting, Performance Measures Committee, Other Updates (Action Item)

- a. Introduction: Lavonna Martin, H3
 - This item is to give updates on the community's system of care and what we've been up to the last few months
 1. Working on PIT Report Out, Annual Report, attending conferences and educating about best practices, preparing for using HEAP dollars, growing our team. We're thinking about how to build capacity internally to grow our system of care
 2. Going to do a cursory overview of the Point-in-Time Count -- will give a more in-depth report out on Aug 20 meeting.

3. In addition, we're also working to understand gaps in our system. Working with state TA providers to support:
 - a. 1) Systems Mapping
 - b. 2) Integrating Rapid Rehousing (RRH) in Coordinated Entry (CE)
 - c. 3) System Performance Measures
 4. Going to ask that the Board have a special meeting in a few weeks to bring this forth.
- b. Dana Ewing, PIT Count Overview
- Sharing PIT data with service data to give a bigger picture of what is happening
 - Purpose for the PIT Count
 1. Required to conduct annual sheltered counts & biennial unsheltered counts. Contra Costa conducts both counts every year.
 2. Inform federal & state funding
 - Sheltered Count: 100% HMIS coverage rate this year
 - Unsheltered Count:
 1. Surveys conducted at service & community sites
 2. Collect observations for the first night of count, led by CORE
 - Results
 1. 2018-2019
 - a. 3% increase
 - b. 668 in shelters, 11% families
 - c. 1,627 people unsheltered, 3% families
 2. One-third of the people served in a year are identified via PIT
 - California One-year shifts
 - Subpopulations
 1. 29% of adults report having a disability
 2. 114 Vets (14% increase in one year)
 3. Age breakdown
 - a. No minors were unaccompanied
 - Shelter Capacity
 1. Much higher need for single adult shelter beds
 2. Smaller need for shelter beds for families (but still there)
 - Wrap-up
 1. Report online
 2. Dive into shifts around subpopulations & regional differences
 - Questions:
 1. Tracy: We do the count every year but it's hard to compare that to the other counties since they need to compare between 2017 and 2019.

- a. Dana: We're diving into that. Can look at 5-year data. Will look across county and Bay Area.
 - b. Lavonna: Reason that Contra Costa does a count every year, is that so we aren't surprised
 - i. Know our shift happened between 2017 and 2018, did work between 2018 and 2019 to keep increase to ~3%
 - ii. Will provide context for much of this in a few more weeks
 - c. Dana: Data is only as good as the data collection. Integrate into our service data to give a better picture of what is happening.
 - d. Lavonna: Only a one day count strips the context away.
2. Community member: What is meant by shelter?
 - a. Lavonna: So shelter, by HUD's definition, is a location that is a temporary destination -- typically 18 months or less. It can also be for one-night.
 3. Doug: What struck me is the slide with the comparison of the year to year changes between counties. Is it typical to have such big differences?
 - a. Dana: Missing the raw numbers and also context. All surrounding counties around Pasadena saw increases.
 - i. Data is from Hub for Urban Initiatives
 4. Teri: Of this data the one that strikes me is San Diego. They've been working hard, and got special funding
 5. Tony: Does Vet by-name list align with this?
 - a. Tracy: It's surprising that it's increased more than the overall number - we've really concentrated on this
 - i. We know who the 114 vets are because we have a by-name list
 - ii. Lavonna: the PIT count is a third of the by-name list
 - b. Tony: from a planning perspective, thinking about VASH, good to know how many people are out there, which funding can address these numbers
 - c. Lavonna: You also have to remember inflow vs. outflow - as people are impacted by housing crisis, there needs to be an opportunity to quickly exit homelessness.
 - d. There are new veterans coming in each month, can't think of these as static numbers
 6. Why was there a 3% increase?
 - a. Lavonna: that analysis will be put into context at our August 20th meeting and in our annual report

- b. There have been changes to our system of care over the past year that may have impacted the numbers
 - c. Dana: Our service data gives us more context as well

7. FY2019 HUD Continuum of Care (CoC) NOFA Release; new project scoring tools edits; and, formation of Review and Rank Ad Hoc Committee (Action Item)

- a. Presented by Emily Firgens, Homebase
- b. CoC Program NOFA Release Overview
 - National competition for homelessness funding with over \$2.3B available across the U.S. Applications Due September 30, 2019
 - Contra Costa will apply for renewal and new project funding
 1. New projects can include: PSH, RRH, Joint TH-RRH, HMIS, and Coordinated Entry

2. DV Bonus Funding Available Again for RRH, TH-RRH, and Coordinated Entry
 - Teri: does HUD still have priority populations for TH?
 1. Emily: HUD is not funding TH by itself, but rather only as a joint TH-RRH project; you can apply for it under the DV bonus (dedicated to DV population) or CoC bonus (any homeless population)
- c. The 2019 CoC NOFA emphasizes:
 - Evidence-based practices
 - Data-driven decision making
 - System performance: Investing in projects that will improve the system as a whole
 - Encouraging connections to employment & increasing income
 - Low Barriers to Housing: No preconditions for housing placement

- e. New Project Scoring Tool Edits – better align with the CoC NOFA language.

 - Council previously requested one more opportunity to look at these priorities after the release of the NOFA
 - Leslie: not necessarily proposing a change now, but after this NOFA, we should look at relative point value of DedicatedPLUS and Joint TH-RRH projects - let's discuss before next year
 1. Lavonna: our system resource map will tell us what the gaps and needs are to inform future tools; unfortunately we don't have it for this year, but will have a better picture of our system's needs for future scoring tools
 - Manuel: victim-centered isn't the best language
 1. Emily: this is to mirror language that HUD uses in the NOFA

8. State Policy Update: 2019-2020 State Budget and Legislation

- a. Presented by Emily Firgens, Homebase
- b. 2019-2020 State budget updates:
- Includes over \$1 Billion in funding for homelessness programs.
 - We have some information on new programs based on language in the budget and trailer bills.
 - But, still a number of details need to be worked about how the funding is administered and new programs are implemented.
- c. Overview of state funding by department (see slides for more details)
- d. Doug: for the new funding under the budget, what do we know about any process for RFPs as a CoC? How do we figure out how to spend the money?
- Lavonna: the state needs to give us clarity on what will be required by communities; we'll know more over the next couple of months, specifically for HHAPP, which will look slightly different than HEAP

because 13 largest cities get allocations, plus Counties instead of just CoCs

- e. Lindy: do the federal changes to CalFresh fall under the policy priorities that the Board of Supervisors already enables us to look at?
 - Lavonna: H3 can look at that and help with bringing a recommendation to the BoS from the Council
 - Lynn is already watching this on the policy side

9. Community Announcement

- a. Lindy - East Bay Leadership Council philanthropy award - opportunity to nominate someone who makes donations, or a grant maker - great way to recognize generosity - go to the website and fill out the nomination form, with award breakfast in November
- b. Tracy - by name list for Veterans number is 195 as of July 12
 - Teri - is veteran status self-reported in the PIT?
 1. Yes, we ask it really carefully to ensure good data quality
- c. Leslie - some of the BSCC reentry money will come to SHELTER Inc., who applied and was funded for an adult reentry program covering Contra Costa and Solano Counties, \$3M over 3.5 years, housing first, coordinated entry involved
- d. Manjit - we are partnering with Bay Church Concord, plus CORE Team, County Medical to provide mobile showers starting next Wednesday by Loaves and Fishes for 4-5 hours, connect to services, haircuts, clothes, etc. - excited!
